

Request of self-certification of the data referred to in article 4, para. 4.7 of AEEG's Decision 50/2005

Reference is made to Decision 50/05 adopted by AEEG (Autorità per l'energia elettrica e il gas - electricity & gas regulator) concerning *"Provisions on monitoring of the electricity wholesale market and of the ancillary services market"*, as amended by Decision 05/06 by the same AEEG. Article 4, para. 4.6 thereof stipulates that *"for the purposes hereof, unless otherwise specified, market participants and dispatching users shall be considered jointly, if they entertain relationships of control or association falling under the types covered by Article 7 of Law no. 287 of 10 October 1990". Moreover, Art. 4, para. 4.7 of the same Decision provides that <i>"for the purposes of para. 4.6, market participants and dispatching users shall provide Gestore del Mercato, Gestore della Rete and AEEG with all the data required for assessing whether their relationships of control or association fall under the types specified in Article 7 of Law no. 387 of 10 October 1990".*

Therefore, under Article 4, para. 4.7 of the same Decision, GME (Gestore del Mercato Elettrico SpA) hereby requests Market Participants and Dispatching Users to provide a self-certification stating whether they entertain or do not entertain the types of relationship of control or association covered by Article 7 of Law 287/1990 with other Market Participants, other Dispatching Users or parties authorised to enter into electricity purchase and sale contracts off the Power Exchange.

The self-certification shall be rendered in accordance with Article 47 of Decree of the President of the Republic 445/2000 and sent within 20 January 2007 at the latest according to the modalities indicated in Article 38 of the same Decree, i.e.:

- first by e-mail to <u>monitoraggio@mercatoelettrico.org</u> in this case, the selfcertification shall be signed by digital signature by the company's legal representative and sent as an attachment together with a non-certified photocopy of his/her identity document;
- and then by post to Gestore del Mercato Elettrico SpA, Unità MRS, Viale Maresciallo Pilsudski 92, 00192, Roma in this case, the self-certification shall be signed by the company's legal representative and accompanied by a non-certified photocopy of his/her identity document.

Market Participants and Dispatching Users are also required to notify GME - according to the modalities stated above - of any subsequent change to their company's ownership structure which may have an impact on the above-mentioned relationships of control or association. The notification shall be sent within 30 days at the latest from the occurrence of such change.
